

Eurotypo End User License Agreement.

By downloading, installing and/or embedding any Eurotypo fonts on a computer you are indicating that you agree that the fonts being installed are the exclusive property of Eurotypo, and you have a license of that property under the following terms and conditions of this End User Licensing Agreement “EULA”. If you do not wish to be bound by the Agreement, you cannot access, use or download the Licensed Fonts. Please read this entire document before agreeing to be bound. We recommend that you print this End User License Agreement for further reference.

You hereby agree to the following:

Binding Agreement. You are bound by the Agreement and you acknowledge that all Use of the Licensed Fonts is governed by the Agreement.

1. License Grant.

Eurotypo grants you a non-exclusive, non-transferable license to use the Font Software and Documentation, provided that you agree to the following:

Desktop fonts:

- You are granted a non-exclusive right to use the Font Software to produce and display typefaces on a printer, typesetter, film recorder or other output device. If the Software will be installed on more computers than you are granted for, an additional license must be acquired for every additional computer from Eurotypo.
- Eurotypo grants you the right, exclusively for the purpose of protecting the Font Software and exclusively for yourself, to make one (back-up) copy of the Font Software.
- You agree not to modify, adapt, translate, reverse engineer, decompile, disassemble, alter, redigitize, convert or otherwise attempt to discover the source code of the Font Software.
- You shall not transfer the License Agreement issued to you, to a third party, neither partially, nor completely. This License Agreement is non-transferable, unless you have written permission from Eurotypo.
- Embedding of the Font Software is not permitted. If embedding of the Font Software is desired (e.g. on the internet or cd-rom), an additional license must be purchased. It is not allowed to embed the Font Software in a published document. However there is one exception: you may take a document with the embedded Font Software to a commercial printer or service bureau only if the document is not editable and is only distributed to the printer or service bureau for use by the printer or service bureau.
- Eurotypo reserves all rights not expressly granted to you under this License Agreement.

Restrictions on Use.

You may take a digitized copy of the Font Software used for a particular document to a commercial printer or service bureau for use by the printer or service bureau in printing such document but only if the printer or service bureau represents to you that it has purchased or been granted a license to use that particular Font Software. You may not include the Font Software in a document, you may not distribute the document with the Font Software to third parties, including but not limited to the Internet and cd-rom.

Web fonts:

The Licensed Web Fonts are licensed, not sold, to you for Use only under the terms of this Agreement. Eurotypo, as the licensor, reserves all rights not expressly granted to you. You are hereby granted a non-exclusive, non-assignable, non-transferable (except as expressly permitted herein) license to Use the Licensed Web Fonts on Websites, using the @font-face selector in CSS files, subject to all of the following:

- Licensee must use the Webfont provided by Eurotypo under this EULA. Licensee may not link to the full, CFF OpenType or TrueType font designed for desktop installation.
- Licensee must include the entire commented header in the provided CSS file.
- The total traffic of the Website(s), measured in pageviews per month, may be no greater than the number of pageviews specified in the Receipt.
- Licensee may only install the Webfont on Websites that it owns or controls.
- Licensee may embed Webfont in reports generated by the Website(s), provided that Licensee does not sell the reports for profit.

Restrictions on Use.

- You may not alter the Font Software for the purpose of adding any functionality that such Font Software did not have when delivered to you by Foundry.

- You may not rent, lease, sublicense, give, lend, or further distribute the Font Software, or any copy thereof.
- You may not copy the Font Software. You may make a reasonable number of back-up copies of the Font Software for archival purposes only, and you shall retain exclusive custody and control over such copies. Upon termination of the Agreement, you must destroy the original and any and all copies of the Font Software.

ePub fonts:

You are hereby granted a non-exclusive, non-assignable, non-transferable license (subject to all of the terms and conditions of the Agreement) to: Embed the Font into an unlimited number of copies, format types, and subsequent versions of Ebooks. Modify or convert the Font to improve the font's appearance or performance in an Ebook. Eurotypo reserves all rights not expressly granted to you in this Agreement.

Restrictions on Use.

- Licenses may embed the Font in ONLY the number of Ebook titles indicated in the Receipt..
- For avoidance of doubt, each Issue of an Electronic Publication counts as a separate Electronic Publication, however regional or format variations of each Issue of an Electronic Publication shall not count as a separate Issue.
- The Font Software must be embedded within a file format that protects the Font Software by means of encryption or obfuscation. Formats that meet these criteria include, but are not limited to, PDF, EPUB 2.01, EPUB 3, and KF8. The Electronic Publication must be a non-executable file which is displayed by e-reader software or on e-reader devices. Font Software may not be installed in the operating system on which the ePub runs.

Apps fonts:

Eurotypo grants Licensee a perpetual, worldwide, non-exclusive and non-transferrable license to:

- Embed the licensed Font into an unlimited number of copies and subsequent versions of the Application(s) (“App” or “Apps”).
- Modify or convert the Font to improve the Font's appearance or performance in the App.

Restrictions on Use.

- Licensee agrees to abide by the following requirements and restrictions: a. Licensee may embed the Font into ONLY the number of Apps specified in the Receipt.
- Licensee may not redistribute the Font with the App's source code.
- Licensee may not install the Font in the operating system the App runs on.
- Licensee may not embed the Font in any application software considered to be a plug-in, template, skin or theme.
- Licensee may not embed the Font in an App that enables an end user to create custom typesetting with the Font.
- Licensee may embed the Font in reports that the App saves or exports, provided that the reports are not sold for profit.

Server fonts:

Eurotypo grants Licensee a perpetual, worldwide, non-exclusive and non-transferrable license to:

Install the Font Software on a Licensed Server or incorporate the Font Software into a product and install the product on the Licensed Server, and to use the Font Software on Development Servers solely for internal development use, in each case for Internal Use only, to create or allow End Users to create Embedded Documents that are not Commercial Products with Printing and Viewing Rights and Editing Rights, distribute such Embedded Documents to End Users, and grant End Users the right to Use the Font Software to print, view and edit the Embedded Documents. Eurotypo reserves all rights not expressly granted to you in this Agreement.

Restrictions on Use.

- You may only install the Font Software on the Licensed Servers and Development Servers and not on any other computer or processing unit.
- You agree that the Font Software shall be incorporated in an Embedded Document in such a manner that it cannot be extracted from the Embedded Document, will not be usable except with Embedded Document, and cannot be used or accessed by any unauthorized third party from a Licensed Server, Development Server or otherwise.
- All Use of the Font Software by an End User shall be pursuant to an End User Agreement which restricts the End User's right to Use Font Software to create, modify, or edit a document except on the Licensed Servers as well as prohibits the distribution of an Embedded Document by the End User.
- You agree that you will take no action which will have the direct or indirect effect of causing the Font Software to become Publicly Available Software or otherwise be subject to a Publicly Available Software agreement.

2. Alterations, transfer and copies of the Font Software.

- You may not alter the Font Software for the purpose of adding any functionality that such Font Software did not have when delivered to you by Foundry.
- You may not rent, lease, sublicense, give, lend, or further distribute the Font Software, or any copy thereof.
- You may not copy the Font Software. You may make a reasonable number of back-up copies of the Font Software for archival purposes only, and you shall retain exclusive custody and control over such copies. Upon termination of the Agreement, you must destroy the original and any and all copies of the Font Software.

3. Intellectual and Industrial Property Rights.

You agree that the Licensed Fonts are protected by the copyright law and other intellectual and industrial property rights of Spain and the European Community, by the copyright law and other intellectual and industrial property rights of other nations, and by international treaties.

The Font Software is protected by copyright law. Eurotypo is the sole, exclusive owner of all intellectual property rights, including rights under copyright and trademark law. Licensee agrees not to use the fonts in any manner that infringes the intellectual property rights of Eurotypo or violates the terms of this EULA. Licensee will be held legally responsible, and indemnifies Eurotypo, for any infringements on the foundry's rights caused by failure to abide by the terms of this EULA.

4: Limited Warranty

Eurotypo warrants the product to be free from defects in materials and workmanship under normal use for a period of twenty one (21) days from the date of delivery as shown on Receipt. Eurotypo's entire liability, and Licensee's exclusive remedy, for a defective product shall be, at Eurotypo's election, either (1) return of purchase price or (2) replacement of any such product that is returned to Eurotypo with a copy of the Receipt. Eurotypo shall have no responsibility to replace the product or refund the purchase price if failure results from accident, abuse or misapplication, or if any product is lost or damaged due to theft, fire, or negligence. Any replacement product will be warranted for twenty one (21) days.

This warranty gives Licensee specific legal rights. Licensee may have other rights, which vary from state to state.

EUROTYPO DOES NOT AND CANNOT WARRANT THE PERFORMANCE OR RESULTS YOU MAY OBTAIN BY USING THE FONT SOFTWARE. THE FOREGOING STATES THE SOLE AND EXCLUSIVE REMEDIES FOR EUROTYPO'S BREACH OR WARRANTY. EXCEPT FOR THE FOREGOING LIMITED WARRANTY, EUROTYPO MAKES NO WARRANTIES EXPRESS OR IMPLIED, AS TO NON-INFRINGEMENT OF THIRD PARTY RIGHTS, MERCHANTABILITY, OR FITNESS FOR ANY PARTICULAR PURPOSE. IN NO EVENT WILL EUROTYPO BE LIABLE TO YOU FOR ANY CONSEQUENTIAL, INCIDENTAL OR SPECIAL DAMAGES, INCLUDING ANY LOST PROFITS, BUSINESS INTERRUPTION, LOSS OF BUSINESS INFORMATION, LOST DATA OR LOST SAVINGS. EVEN IF A EUROTYPO REPRESENTATIVE HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, OR FOR ANY CLAIM AGAINST YOU BY ANY THIRD PARTY. You agree to indemnify and hold Eurotypo harmless from and against any claims or damage which may result from your breach of this License Agreement.

5: Termination.

The license is effective until terminated. Eurotypo has the right to terminate your license immediately if you fail to comply with any terms of this Agreement. In addition, Eurotypo reserves the right to claim punitive damages. Upon such termination you will destroy the original and any copies of the Font Software and related documentation and cease all use of the Trademarks.

6: Governing Law.

You acknowledge that you have read this Agreement, understand it and that it is the complete and exclusive statement of your Agreement with Eurotypo and that your obligations under this Agreement, shall inure to the benefit of the Eurotypo licensors whose rights are licensed under this Agreement. You agree that the Licensed Fonts may not be shipped, transferred or exported into any country or used in any manner prohibited by the Spanish Export Administration or any applicable export laws, restrictions or regulations.

This agreement will be governed by the laws in force in Spain and the European Community.

7: Entire Agreement.

Entire Agreement this EULA, in conjunction with the receipt that accompanies each Font licensed from Eurotypo, constitutes the entire agreement between Eurotypo and Licensee.
